MannKind Reports Second Quarter Financial Results

VALENCIA, Calif.--(BUSINESS WIRE)--Sept. 1, 2004-- MannKind Corporation (Nasdaq:MNKD) today reported financial results for the second quarter and six months ended June 30, 2004.

For the second quarter of 2004, total operating expenses were \$18.4 million, compared with \$13.2 million in the second quarter of 2003. Research & Development (R&D) expenses increased by \$5.0 million to \$14.3 million primarily due to the increased expenses associated with expanded clinical trials and related support for the Company's Technosphere[®] Insulin product. General and administrative (G&A) expenses increased by \$0.2 million to \$4.1 million. The net loss for the second quarter of 2004 was \$18.2 million versus a net loss of \$13.1 million in the second quarter of 2003. Net loss per share was \$0.91 in the second quarter of 2004 compared with a net loss of \$0.79 for the comparable 2003 period. Net loss per share, when calculated on a pro forma basis to give effect to the conversion of preferred stock into common stock upon the closing of MannKind's initial public offering on August 2, 2004, was \$0.73 in the second quarter of 2004.

For the first six months of 2004, operating expenses totaled \$35.0 million compared with \$33.6 million in the first half of 2003. R&D expenses were \$27.1 million, up \$6.2 million, again related primarily to the expansion of clinical trials of MannKind's Technosphere[®] Insulin program. G&A expenses were \$7.8 million, a decrease of \$4.9 million from the first half of 2003, when the Company consolidated its California operations into a single facility. For the first half of 2004, the net loss was \$34.7 million, versus a net loss of \$33.4 million in the first half of 2003.

Cash, cash equivalents and marketable securities at June 30, 2004 were \$41.3 million, compared with \$55.9 million at December 31, 2003. Subsequent to June 30, 2004, MannKind completed its initial public offering, resulting in net proceeds of approximately \$83.6 million, including \$4.0 million in proceeds from the exercise of the underwriter's over-allotment option.

MannKind focuses on the discovery, development and commercialization of therapeutic products for diseases including diabetes, cancer, inflammatory and autoimmune diseases. The Company's lead product, the Technosphere[®] Insulin System, which is currently in late Phase II clinical trials for the treatment of diabetes, consists of a proprietary dry powder Technosphere[®] formulation of insulin that is inhaled into the deep lung using MannKind's MedTone inhaler. Early indications show MannKind's proprietary Technosphere[®] Insulin System's performance characteristics, convenience and ease of use have the potential to change the way diabetes is treated.
